Households enrolled in the National Health Insurance Scheme are required to declare their income every year.

Declaring Income for the Calculation of the National Health

Insurance Premiums:

There is a system in place whereby the premiums for National Health Insurance decrease in line with one's income, but if people do not declare their income, they will not be eligible to receive these deductions. Therefore, those aged nineteen years and over and who have not filed an income declaration (including those who do not have an income) are required to submit an "National Health Insurance Premium Income Declaration Form". Income declarations must be submitted every year. Those who are in receipt of an income are required to submit tax returns.

*The following is a list of people who are not required to declare their income for the National Health Insurance Premiums

· Those who have filed final, municipal or prefectural tax returns

• Those who have completed year-end tax adjustments at their workplace and have had their income declaration submitted to Chiba City by their workplace

• Those who are only in receipt of public pensions such as the National Pension or the Employees' Pension Insurance (those in receipt of non-taxable pensions such as the Disability Pension and Survivor's Pension or non-taxable income such as social welfare benefits are required to declare their income in order to calculate the premiums)

· Household members under the age of nineteen who did not receive an income as of the 1st of January

Required Documents:

1. Documents showing income such as the "Withholding Tax Certificate"

2.Identity verification documents (residence card, My Number Card, driver's license) % Please prepare documents showing the insured person's insurance number to ensure that the declaration process goes smoothly (National Health Insurance Premium Notification, National Health Insurance Qualification Document)
